Pursuant to the Order from the February 16, 2010 hearing, Plaintiff Leader Technologies, Inc. ("Leader") hereby encloses the materials requested as part of Your Honor's *in camera* review.

Leader Privilege Logs

Regarding Leader's privilege logs, we have included Leader's original privilege log served on November 20, 2009, and also Leader's supplemental privilege log served on January 15, 2010. All emails identified in IP Investment Group, LLC's privilege log were logged in Leader's January 15 supplemental privilege log.

As Your Honor requested, we have also included in the enclosed materials Leader's seventeen-page letter to counsel for Facebook, dated February 5, 2010, identifying the authoring attorney or requesting attorney for the entries Facebook identified in Leader's privilege log.

Identification of Never Documents

On December 21, 2009, Facebook attached to their letter brief Neyer production document bates numbered NEYER 000103 (Exhibit 1) and Neyer production document bates numbered NEYER 000208 - 218 (Exhibit 2) (D.I. 183, 184). Those documents were produced by Neyer Holding Corporation in response to Facebook's November 23, 2009 subpoena. Exhibit 1 was listed on Leader's privilege log as Entry No. 386. Exhibit 2 was logged on Leader's privilege log as Entry No. 317. We have provided in the enclosed materials the privileged document corresponding to Entry No. 386, and the privileged document corresponding to Entry No. 317. Additionally, for clarification and context, we have provided the metadata for those

two documents, which demonstrates why Entry No. 317 was logged with the date November 20, 2007, and Entry No. 386 was logged with the date October 10, 2007.

Identification of IP Investment Documents

The other set is the unredacted version of IP Investments documents as provided to IP Investment. In particular, we have placed pink cover slip sheets as an indication of email attachments.
