DETAILED ACTION

1. Claims 1-20 are presented for examination. This office action is in response to the Appeal Brief field on April 23, 2004.

2. In view of the Appeal Brief filed on 23 April, 2004 and response to conference decision, PROSECUTION is hereby reopened.

Allowable Subject Matter

3. Claims 1-20 are allowed over prior art. The following is a statement of reasons for allowance:

For the claims 1, 14 and 18, the prior art teaches (Rennison et al, U.S. Patent No. 6,154,213), the system for navigating large document collection sets and finding topics and subtopics and finally categorizing document based on topics that the documents include. User query is used for against topics. Defining an organized classification of document content with each class in the organized classification of document content having associated with a classification label. The system retrieves information.

The prior art does not teach the combination steps, as follows:

Automatically identifying a stet of entities in the selected document content for searching additional information related, automatically categorizing the selected

document content using the organized classification of document content for assigning the selected document content a classification label from the organized classification of content, and automatically formulating the query to restrict a search at the information retrieval system for information concerning the set of entities to the category of information in the information retrieval system identified by the assigned classification label.

The dependent claims 2-13, 15-17 and 19-20, being definite, further limiting, and fully enabled by the specification, are also allowed.
