**RECOMMENDATION**

WHEREAS, pursuant to paragraph 2(a) of the Procedures to Govern Mediation of Appeals from the United States Bankruptcy Court for this District dated September 11, 2012, teleconferences were held on May 16 and 20, 2013, for an initial review and discussion with counsel to determine the appropriateness of mediation in this matter;
