



## POINTS AND AUTHORITIES IN SUPPORT OF MOTION

1. The Murchison Brothers Partnership was dissolved by the death of John Murchison, Jr., a partner, on October 29, 1994, more than 12 years ago. Plaintiff has been entitled to a final accounting of the Partnership from defendant George Murchison at all times since dissolution, but has not received the accounting.

2. This action was filed on February 19, 1998, more than 9 years ago. Count IV of the complaint sought an accounting for the Partnership. By Order filed August 10, 2001 (#132), more than 6 years ago, the Court granted plaintiff judgment requiring that "George Murchison shall provide for an accounting of the Murchison Brothers Partnership's assets to plaintiff and distribute to plaintiff any interest in the Partnership that remains due her."

3. George Murchison has never provided an accounting of the Murchison Brothers Partnership's assets to plaintiff, and has never distributed to plaintiff the interest in the Partnership which remains due to her.

4. By Final Order filed June 12, 2007 (#232) the Court required George Murchison to "provide the plaintiff with a final statement of receipts and disbursement of the Murchison Brothers Partnership prepared in a customary format using generally accepted accounting practices...."

5. George Murchison has not provided plaintiff with a final statement of receipts and disbursement of the Murchison Brothers Partnership prepared in a customary format using generally accepted accounting practices.

6. The Court has not stayed its August 10, 2001 Order (#132) or its June 12, 2007 Final Order (#232). George Murchison has not complied with either of these orders, both of which are final.

**WHEREFORE**, plaintiff prays that the Court set a 30-day deadline, and such other requirements as the Court deems appropriate, for George Murchison to comply with the provisions of the August 10, 2001 Order (#132) and the June 12, 2007 Final Order (#232) applicable to the Murchison Brothers Partnership.
