**CERTIFICATION OF PLAINTIFFS' SUPPLEMENTAL RECORD**



1. I am the Interim President of the Plaintiff Farm-to-Consumer Legal Defense Fund. I have been acting in this capacity November 1, 2008.
2. Prior to serving as Interim President, I was a Board member of the Fund and have acted in that capacity since at least July 4, 2007.
3. The documents in this Plaintiffs Supplemental Record are being provided in accordance with this Court's Minute Order dated May 18, 2009.
4. Plaintiffs informed the Court via a notice (Doc. #55) filed on May 29<sup>th</sup> that they would reserve their rights to file a Supplemental Record in the event USDA failed to file the documents specified in the Court's Minute Order of May 18<sup>th</sup>.




