ORDER

Plaintiff, proceeding pro se, filed the above-entitled action. The matter was referred to a United States Magistrate Judge pursuant to Local Rule 72-302(c)(21).

On July 18, 2001, the magistrate judge filed findings and recommendations herein which were served on all parties and which contained notice to all parties that any objections to the findings and recommendations were to be filed within ten days. On August 2, 2001, plaintiff filed a request for extension of time to file his objections. Good cause appearing, this request is granted.

Both parties have filed objections to the findings and recommendations.

In accordance with the provisions of 28 U.S.C. § 636(b)(1)(C) and Local Rule 72-304, this court has conducted a <u>de novo</u> review of this case. Having carefully reviewed the entire



file, the court finds the findings and recommendations to be supported by the record and by proper analysis.

Accordingly, IT IS HEREBY ORDERED that:

- 1. Plaintiff's August 2, 2001, motion for an extension of time to file his objections is granted;
 - 2. The findings and recommendations filed July 18, 2001, are adopted in full;
- 3. Defendant's May 4, 2001, motion to dismiss is granted insofar as plaintiff complains about permitting a chaplain (or the President) from making any prayer at the Presidential inauguration. However, the motion is denied insofar as plaintiff is attacking the specifics of the prayer as a violation of the Establishment Clause;
- 4. Within twenty days of the date of this order defendant shall file an answer to the complaint.
