

As I watched this inauguration, I was hurt by the lack of inclusiveness demonstrated by the Reverend Rick Warren who delivered the invocation. His words were clearly addressed to the Christians in the audience, and in no way were intended to include people like me. I wanted to feel a part of the inauguration in this year in particular, and the tone of this invocation made me feel like an outsider.

I am currently 44 years old, so I expect to witness ten or more future inaugurations during my lifetime.
