DECLARATION OF LIEUTENANT COMMANDER STEPHEN C. REYES, JAGC, USN

- 1. I am Lieutenant Commander (LCDR) Stephen C. Reyes. I am an active duty member of the United States Navy, Judge Advocate General's Corps, and I am currently assigned to the Office of the Chief Defense Counsel (Office of Military Commissions) as a defense counsel.
- On July 7, 2008, the Chief Defense Counsel, Colonel Steven H. David, U.S.
 Army, detailed me as the Detailed Defense Counsel for Abdu Rahim Al-Nashiri, ISN 10015.
 Mr. Al-Nashiri has been confined at the United States Navy Base in Guantanamo Bay, Cuba since 2006.
- 3. Upon being detailed, I was informed of Mr. Scott Fenstermaker's claim that he represents Mr. Al-Nashiri before the Military Commissions and Federal Courts.
- 4. As detailed counsel, I met with Mr. Al-Nashiri on numerous occasions in Guantanamo Bay, Cuba. During these meetings we discussed his counsel rights and choices. We also discussed Mr. Fenstermaker's claim that he represents Mr. Al-Nashiri. At these meetings, Mr. Al-Nashiri made it clear that he does not desire Mr. Fenstermaker's assistance and does not authorize Mr. Fenstermaker to make an appearance or file any pleadings on his behalf in any jurisdiction
- 5. On July 25, 2008, Mr. Al-Nashiri signed a written document outlining who he authorizes to represent him and in what jurisdictions. Mr. Al-Nashiri intentionally excluded Mr. Fenstermaker from this list.
- 6. On September 2, 2008, after discovering that Mr. Fenstermaker continued to make claims that he represented Mr. Al-Nashiri, I wrote an e-mail and sent a written letter to Mr. Fenstermaker informing him that the client does not desire his assistance as counsel and notifying Mr. Fenstermaker that under his state bar rules he is prohibited from communicating to Mr. Al-Nashiri about the subject of my representation.
