

(2) I agree that the Memorandum of Understanding and any other non-disclosure agreement signed by me will remain forever binding on me;

(3) I have received, read, and understood the Protective Order entered by the United States District Court for the District of Columbia in the case captioned Abd Al Sattar v. Bush, et al., Case No. 08-1236, and I agree to comply with the provisions thereof.


