With regard to my request below for a visit accomodation:

Well we didn't get this accomplished for the March trip, but we're going down in mid-April. Could you check if we can make this happen? I still do not know which camp Mr. Idris is housed in. When we were there in March and asked the captain he purported not to know where Idris was housed.

To be clear, I am requesting:

- 1. If Mr. Idris purports to decline our request for a visit, we request that we be permitted to go back to his cell, with our interpreter, to ask him in person if he will consider meeting with us.
- 2. Barring (1), as a secondary request we would ask that we be permitted to meet with Mr. Idris in the camp in which he is housed, rather than forcing him to be transferred to a separate camp for the meeting.

The second request above has been agreed to by DOJ lawyers with respect to other clients we represent in other cases.

Please let me know if you can provide either of these accomodations for our upcoming trip in mid-April.

John,

We are planning another trip to Guantanamo next week, and we hope to visit with Mr. Idris. In our conversations with DOJ counsel (John Siemietkowski) with respect to one of our other clients (Mr. Sattar, ISN 309), who also declined to meet with us during our first trip, we were offered the following proposal for attempting to meet with our client: the DOJ offered

(1) to let us meet with the detainee in one of the interview rooms located inside his camp, so that the detainee would not need to be transferred from one camp to another; and (2) if the detainee would prefer to meet only with the interpreter first to build rapport, the detainee (in the interview

room) may meet with the interpreter alone, briefly, before the lawyers come in.

Let me know you are willing to offer these same modest accomodations for our upcoming visit with Mr. Idris.
