Greetings. Thank you again for your patience and assistance. I am following up on my revised request to visit Mr Dokhan, a client of a clinic at UT Law School. I understand that you are not responsible for approving or denying visits but that JTF must approve the visit. I am very concerned as it is now two weeks from the requested visit date. Given that it took over a month for a response, which in fact was neither a denial nor an approval, to my initial request made over a month ago, it may take JTF the same amount of time to respond to my revised request, which of course would mean that the visit date would pass without any word on whether my visit is approved or denied. Also, as JTF knows, the flights to and from Guantanamo fill up very quickly such that there may be no available flights by the time JTF responds to my revised request.

In light of the circumstances, including Judge Hogan's order requiring client authorizations by October 29, and the need to try to visit with my client, I believe we will have to go to court to seek a timely resolution. I would prefer not to go to court as it is a waste of judicial resources and the parties' resources but I don't see that there are any other options at this point. If there is no response to my visit request by 4pm on Monday October 6, I will have to seek a resolution before Judge Hogan.
