JOINT MOTION TO CONSOLIDATE BRIEFING SCHEDULE

Pursuant to Federal Rule of Civil Procedure 6(b), the parties hereby request that the Court consolidate the schedule for further briefing in this matter. On June 26, 2009, the Court entered the briefing schedule proposed by joint motion on June 25, 2009. *See* dkt. no. 16; Minute Order (June 26, 2009). Under this schedule, Plaintiff's Opposition to Defendants' Motion to Dismiss was due July 2, 2009; and Defendant's Reply to Plaintiff's Opposition was due August 10, 2009. *Id.* Subsequently, Plaintiff timely filed his Opposition and simultaneously submitted a Cross-Motion for Summary Judgment, relying on the same Memorandum of Law in support of both pleadings. *See* dkt. no. 17; dkt. no. 18.

The interests of economy and efficiency would best be served by permitting briefing on the two sets of pleadings to continue on a consolidated basis. The parties therefore request that the briefing schedule entered on June 26, 2009 be modified to reflect that Defendant's response to Plaintiff's Cross-Motion for Summary Judgment also be due on August, 10, 2009.

A proposed order granting the relief requested is included with this motion.
