NOTICE OF WAGE GARNISHMENT

You are hereby notified that a portion of the non-exempt disposable wages of Defendant are being taken by the United States Government, which has a Court judgment in the above-captioned criminal case ordering that Defendant pay restitution in the sum of \$221,019.76. A balance of \$215,672.26, including penalties, remains outstanding.

In addition, you are hereby notified that there are exemptions under the law which may protect some of the property from being taken by the Government if Regina Williams can show that the exemptions apply. Attached is a description of the exemptions that apply in garnishments arising out of a federal criminal judgment.

If you are Regina Williams, you have a right to ask the Court to return your property to you if you think you do not owe the money to the Government that it says you do, or if you think the property the Government is taking qualifies under one of the above exemptions.

If you want a hearing, you must notify the court of this within 20 days after receipt of this notice.

Your request must be in writing. If you wish, you may use the form attached to this notice to

request the hearing. You must either mail it or deliver it in person to the Clerk of the United

States District Court at United States Courthouse, 333 Constitution Avenue, Room 1225,

Washington, D.C. 20001. You must also send a copy of your request to counsel for the United

States, Judith A. Kidwell, Assistant U.S. Attorney, at 555 4th St., N.W., Room E-4212,

Washington, D.C. 20530, so the Government will know you want a hearing.


The hearing will take place within 5 days after the Clerk receives your request, if you ask for it to take place that quickly, or as soon after that as possible. At the hearing, you may explain to the judge why you believe that the property the Government has taken is exempt or why you think that you do not owe the money to the Government. If you do not request a hearing within 20 days of receiving this notice, a portion of your non-exempt disposable wages will be paid on your debt.

If you think you live outside the Federal judicial district in which the Court is located, you may request, not later than 20 days after you receive this notice, that this proceeding to take your property be transferred by the court to the Federal judicial district in which you reside. You must make your request in writing, and either mail it or deliver it in person to the Clerk of the Court at United States Courthouse, 333 Constitution Avenue, Room 1225, Washington, D.C. 20001. You must also send a copy of your request to Judith A. Kidwell, Assistant U.S. Attorney, U.S.

Attorney's Office, 555 4th Street, N.W., Room E-4212, Washington, D.C. 20530, so the Government will know you want the proceeding to be transferred.

Be sure to keep a copy of this notice for your own records. If you have any questions about your rights or about this procedure, you should contact a lawyer, an office of public legal assistance, or the clerk of the court. The clerk is not permitted to give legal advice, but can refer you to other sources of information.
