



MOTION FOR CERTIFICATION THAT OUT OF STATE WITNESS IS NEEDED IN THIS STATE

Comes now Defendant, Jerrod M. Peterson, by and through counsel, Andrew V. Jezic, requests that this court issue a certificate under the seal of the court requiring the appearance of material witness Deputy George Bergan, and the production of documents and/or records within his custody and control pursuant to Cts. & Jud. Proc. § 9-303, and in support thereof states the following:

- 1. The Defendant is charged with First Degree Murder and related charges.
- 2. Trial is scheduled to begin on August 15, 2011 and is expected to last five to six days.
- 3. Rorie Smith, General Counsel of the Court Services and Offender Supervision Agency of the District of Columbia is a material witness in this case.
- 4. Rorie Smith is the custodian of the probation records and file of James McLaurin, a probationer in the District of Columbia.
 - 5. James McLaurin is a material witness for the State in this case.
