27 **PLAINTIFF TRANS VIDEO ELECTRONICS, LTD.’s**
28 **COMPLAINT FOR PATENT INFRINGEMENT**

Plaintiff Trans Video Electronics, Ltd. (“Trans Video”), by and for their Complaint against defendant Nintendo of America, Inc. and Nintendo Co., Ltd. (together “Nintendo”) allege as follows:

1 **NATURE OF THE CASE**

2 1. This is an action for patent infringement arising under the patent laws of the United
3 States. Trans Video holds the rights in U.S. Patent No. 5,991,801 (“the ’801 patent”) and U.S.
4 Patent No. 5,594,936 (“the ’936 patent”). The United States patent laws grant the holder of a patent
5 the right to exclude infringers from making, using, selling or importing the invention claimed in a
6 patent, and to recover damages for the infringer’s violations of these rights, and to recover treble
7 damages where the infringer willingly infringed the patent. Trans Video is suing Nintendo for
8 infringing its patents, and doing so willfully. Trans Video seeks to recover damages from Nintendo,
9 including treble damages for willful infringement, as well as injunctive relief to end Nintendo’s
10 further infringement.
11

12 **THE PARTIES**

13 2. Plaintiff Trans Video is a corporation incorporated under the laws of the State of
14 Indiana and has its principal place of business at 4115 Wisconsin Ave., NW, Suite 208, Washington,
15 DC 20016.
16

17 3. Upon information and belief, Defendant Nintendo of America, Inc. is a corporation
18 organized under the laws of the State of Washington with its principal place of business at 4820
19 150th Avenue NE, Redmond, Washington 98052-5111. It may be served via its registered agent, CT
20 Corporation System, at 350 N. Saint Paul St., Suite 2900, Dallas, Texas 75201-4234. Nintendo does
21 business in the District of Columbia.
22

23 4. Upon information and belief, Defendant Nintendo Co., Ltd., is a corporation
24 organized under the laws of Japan with its principal place of business in Kyoto, Japan. It may be
25 served via its officers and/or Directors at its corporate headquarters at 11-1 Kamitoba Hokotate-Cho,

2 Nintendo Co., Ltd.

3 5. The entities referred to above in paragraphs 3 and 4 are hereinafter collectively
4 referred to as “Nintendo” and/or “Defendants.”
5

6 **JURISDICTION AND VENUE**

7 6. This is an action for patent infringement arising under the patent laws of the United
8 States of America, more specifically under 35 U.S.C. § 100, *et seq.* Subject matter jurisdiction is
9 proper in this Court pursuant to 28 U.S.C. §§ 1331 and 1338.

10 7. Personal jurisdiction and venue are proper in this judicial district pursuant to
11 28 U.S.C. §§ 1391 and 1400 because, upon information and belief, Defendant, directly or through
12 intermediaries, transacts business in this judicial district, including making, using, operating,
13 distributing, importing, offering for sale or license, selling or licensing, and marketing, supporting
14 and advertising of its products and services in the United States and the District of Columbia.
15 Defendant has sufficient contacts with this judicial district to subject itself to the jurisdiction of this
16 Court.

18 **COUNT 1: INFRINGEMENT OF U.S. PATENT NO. 5,991,801**

19 8. Trans Video incorporates by reference the allegations set forth in the preceding
20 paragraphs.
21

22 9. On November 23, 1999, the '801 patent was duly and legally issued. A Re-
23 examination certificate issued on April 5, 2011. A true and correct copy of the '801 patent is
24 attached hereto as Exhibit A. A true and correct copy of the re-examination certificate is attached as
25 Exhibit B. Trans Video is the assignee and the owner of all right, title and interest in and to the
26 '801 patent. The '801 patent is entitled to a presumption of validity.

1 10. On information and belief, Nintendo has been, and currently is directly, literally
2 and/or upon information and belief, jointly, equivalently, and/or indirectly infringing (by way of
3 inducing infringement by others, and/or contributing to the infringement by others) the '801 patent
4 in the District of Columbia, in this judicial district, and elsewhere in the United States by, among
5 other things, making, using, operating, distributing, importing, offering for sale or license, selling or
6 licensing, and/or marketing, supporting and advertising certain of its products and services,
7 including the Nintendo Channel, the Nintendo Wii, the Nintendo DS and 3DS for video distribution,
8 including downloading, streaming and/or storing, that embody and/or practice the inventions
9 claimed in the '801 patent. Nintendo is thus liable to Trans Video for infringement of the '801
10 patent pursuant to 35 U.S.C. § 271.
11

12 11. Nintendo actively and knowingly has infringed and is infringing the '801 patent with
13 knowledge of Trans Video's patent rights and without reasonable basis for believing that Nintendo's
14 conduct is lawful. Nintendo has also induced and contributed to the infringement of the '801 patent
15 by purchasers, licensees, and users of the Nintendo Channel, the Nintendo Wii, the Nintendo DS and
16 3DS products and services.
17

18 12. On information and belief, Nintendo's infringement of the '801 patent has been and is
19 willful and will continue unless enjoined by this Court. Nintendo has been, or should have been, on
20 notice of the '801 patent and its infringement, and has not ceased its infringing activities.
21

22 13. Trans Video has suffered irreparable harm by Nintendo's acts of infringement of the
23 '801 patent, and will continue to suffer harm unless and until Nintendo's acts of infringement are
24 enjoined and restrained by order of this Court.

25 14. As a result of Nintendo's acts of infringement, Trans Video has suffered and will
26 continue to suffer damages in an amount to be proven at trial.

1 G. That Trans Video be granted pre-judgment and post-judgment interest in
2 accordance with 35 U.S.C. § 284 on the damages caused to it by reason of Nintendo's infringement
3 of the '801 patent and the '936 patent, including pre-judgment and post-judgment interest on any
4 enhanced damages or attorneys' fees award;

5 H. That costs be awarded in accordance with 35 U.S.C. § 284 to Trans Video;

6 I. That Nintendo, its officers, agents, employees, representatives, successors and
7 assigns, and those acting in privity or in concert with any of them, be preliminarily and permanently
8 enjoined under 35 U.S.C. § 283 from infringing in any manner the '801 patent and the '936 patent;
9 and

11 J. That Trans Video be granted such other and further relief as the Court may
12 deem just and proper under the circumstances.
