ORDER

For the reasons provided in the memorandum opinion filed concurrently with this Order, the defendant's motion to dismiss Count II of the complaint insofar as it raises a claim based on an implied contract of fair dealing is **GRANTED**, and the defendant's motion for judgment on the administrative record is **GRANTED**.
