AS TO DEFENDANT ROBERT LEATHERWOOD**



Pursuant to 28 U.S.C. § 1746, I, Francis X. Taney, Jr., declare as follows:



**JUDGMENT BY CONSENT  
AS TO DEFENDANT ROBERT LEATHERWOOD**

**THIS CAUSE** is before the Court upon plaintiff Eros LLC's ("Eros's") Unopposed Motion ("Motion") for Entry of a Judgment by Consent as to defendant Robert Leatherwood ("Leatherwood"). After carefully considering the Motion, and being otherwise fully advised in the premises,

**IT ORDERED AND DECREED THAT:**

1. Plaintiff's motion is granted.
2. On or before March 31, 2008, Leatherwood shall disclose to Eros the names and email addresses of all other persons of whom Leatherwood is aware had access to the Volkov Catteneo account within the Second Life virtual world platform.
3. Leatherwood is hereby permanently enjoined from copying, displaying, distributing and selling any of Eros's merchandise without Eros's permission, and from aiding, abetting, assisting, conspiring with, cooperating with or encouraging any other person or entity

with copying, displaying, distributing and selling any of Eros's merchandise without Eros's permission.

4. Upon Leatherwood's compliance with his obligations under paragraph 1 of this Order, Eros shall arrange for the filing of a stipulation of dismissal with prejudice with respect to this Action.

5. The Court retains jurisdiction over this Action for the purpose of interpreting and enforcing this Order.
