On Wednesday, August 12, 1992, at the request from Mrs. Abele, personnel from this office conducted a sanitary inspection on the above-referenced property. The following are our findings and the corrective actions necessary to comply with state and county regulations:

- A. The septic tank system servicing the house.
  - 1. The tank collapsed.
  - 2. The tank is too small.
  - 3. The bottom of tank is not acceptable (not solid concrete).
  - Only 94 square feet of drainfield and appears to be clogged.
  - 5. Dry well used for disposal of washing machine waste water.

COMPLIANCE: Apply and obtain an onsite sewage disposal permit; install a system as per Chapter 10D-6, F.A.C.

- B. Private potable water system servicing the house and mobile home.
  - 1. Garbage around and over the system.

COMPLIANCE: Remove garbage from area. Sample water to verify it is bacteriologically safe. Time of compliance: I week.

C. Garbage and trash scattered everywhere; some areas with pile of burned garbage, other areas with holes and burried garbage.

COMPLIANCE: Remove garbage and trash and dispose of properly at county sanitary landfill. Time of compliance: 2 weeks.

NOTE: This department will coordinate with Code Enforcement the enforcement of violations. Please do not restore power rights to house until notified by this office that owner is in compliance.


