MEMORANDUM OF LAW

Movant, DEVLIN ENTERTAINMENT, LLC, a Florida limited liability company, by and through its undersigned attorneys, respectfully files this Memorandum of Law in Support of its Objection and Motion to Quash or Modify Subpoena Duces Tecum and as grounds therefor would show to the Court as follows: Rule 45, Federal Rules of Civil Procedure, provides in subparagraph C thereof that protection may be granted to persons subject to subpoena. Specifically, under subsection (3), on timely motion, the Court by which a subpoena was issued shall quash or modify it if it "(i) requires disclosure of a trade secret or other confidential research, development or commercial information. . . ." The subpoena issued in the instant case is directed to a non-party but requires disclosure of operating agreements, capital accounts maintained with respect to this entity's members, any and all financial statements and any and all ledgers which reflect accounts maintained by this entity for the past five years.

Plaintiff's efforts to uncover the financial assets of the Defendant in the instant case should be directed to the Defendant and not the movant. Further, any document production by movant should be limited to the interest, if any, of the Defendant in the instant case.

Plaintiff should be precluded from harassing movant with burdensome discovery requests which are directed to movant solely because the named registered agent of the movant is the same or similar to the registered agent of the Defendant herein.
