Hennigan, M.D., having been duly noticed and having an opportunity to be heard at a hearing held on September 12, 2008, the Court being fully advised in the premises and having entered its Order dated September 19, 2008 [Doc. No. 182] GRANTING the Receiver's Motion, it is hereby

**ORDERED AND ADJUDGED AS FOLLOWS:**

1. All right, title and interest of MWH Investments, LLC, in and to the below described real property, is hereby conveyed and transferred from MWH Investments, LLC, to Michael L. Gore, as Receiver:

Lot B-3, Stecoah View Subdivision, located in Stecoah Township, Graham County, North Carolina, as more particularly described in the General Warranty Deed dated December 12, 2005, recorded at Book 263, Page 389, in the Graham County Registry of Deeds, Stecoah Township, North Carolina ("the Property").

2. Title to the Property is conveyed and transferred to Michael L. Gore, as Receiver, "subject to" all existing liens and mortgages of record.

3. The Receiver is granted authority to immediately list, market and sell the Property, with any sale subject to the approval of the Court.

4. While this Order shall constitute an immediate and automatic conveyance and transfer of the Property to Michael L. Gore, as Receiver, MWH Investments, LLC, through Michael W. Hennigan, M.D., is directed to cooperate with the Receiver by signing any documents that may be required to effectuate this Order, which the Receiver or any title company may reasonably require.
