AFFIDAVIT AS TO ATTORNEYS' FEES AND COSTS

Before me, the undersigned authority, this day personally appeared Steven R. Wirth,  
who after being duly sworn, deposes and states as follows:

1. I am an attorney duly licensed to practice law in the State of Florida. I am a  
partner with the law firm of Akerman LLP ("Akerman"), which represents Wells Fargo, N.A.



successor by merger to Wachovia ("Wells Fargo" or the "Bank") in the above-styled receivership proceedings.

2. I have been practicing law since the year 2000. Since 1999, I have been a member in good standing of the Florida Bar, a member in good standing of the New York Bar, and a member in good standing of the New Jersey Bar. I am a member of Akerman's litigation and bankruptcy practice groups, where my practice includes representing clients in enforcing security instruments and protecting creditors' rights in SEC receivership proceedings. In light of my experience, I am familiar with the amounts customarily charged by attorneys and allowed by courts in matters such as the instant case.

3. Since early 2011, when my firm was retained in this matter, I have been one of the principal attorneys on the file. In that role, I have worked closely with Joseph Shaheen, and supervised the work of Sadie Craig, Ben Diamond, John Dicks, Nora Graziano, Jason Margolin, and others.

4. Wells Fargo retained Akerman represent and preserve its pre-receivership state law property rights and security interests in the Receivership Proceedings. At the time the receivership was filed, Wells Fargo held valid secured claims against the following properties: (1) 841 South Main Street, Graham, North Carolina (the "**Rite Aid Property**"); (2) approximately 420 acres near Asheville, North Carolina in Buncombe and McDowell counties (the "**Laurel Mountain Property**"); (3) 30393 Upper Bear Creek Road, Evergreen, Colorado (the "**Evergreen Property**"); and (4) 464 Golden Gate Point, Unit 703, Sarasota, Florida (the "**Sarasota Property**"). In addition, Wells Fargo held valid secured claims against rents generated from, *inter alia*, the Rite Aid Property.

5. Throughout the Receivership Proceedings, the Receiver has vigorously challenged Wells Fargo's claims and security instruments, often without a legitimate legal basis. First, he objected to Wells Fargo's claims on a number of different theories, including the Bank's alleged complicity in Arthur Nadel's Ponzi scheme. Then, he sought to eradicate the Bank's valid state law property rights through an untenable "claims administration" process. Even now, his "claims administration" process argument persists, as he argues that Wells Fargo does not have an enforceable assignment of rents, despite the Eleventh Circuit's clear ruling in this case that he cannot extinguish state law property rights and security interests. In 2012, the Receiver moved to sell the Bank's collateral despite the Bank's valid liens, the Bank's opposition to the sale, the Receiver's own noncompliance with applicable statutes, and a better offer for the same property. At several points during these proceedings, the Receiver sought to distribute Receivership funds without maintaining sufficient reserves to turn over the Bank's property, necessitating the Bank's objections. These are just some of the examples of how the Receiver's litigation tactics have needlessly damaged Wells Fargo by forcing the Bank to incur attorneys' fees and costs associated with protecting its property rights against myriad attacks.

6. As a direct result of the Receiver's conduct in these Receivership Proceedings, Wells Fargo has incurred hundreds of thousands of dollars defending against baseless challenges.

7. Copies of relevant time sheets are attached to this Affidavit as *Exhibit A*.

8. The time sheets were generated from time records which are kept in the regular course of business and made by persons with personal knowledge of the facts at or near the time

that work is performed. The time records from which Exhibit A was generated are in my custody, supervision, and control and are complete, accurate, and correct.

9. I certify that the task descriptions, time, and fees reflected in the attached time sheets are an accurate accounting of the work performed and time devoted by me and Akerman on Wells Fargo's behalf in this case.

10. After Exhibit A was prepared, I reviewed it and reduced or eliminated time for work which may have been considered duplicative or otherwise unnecessary. I also reduced or eliminated time for work not related to Wells Fargo's defense of the Receiver's challenges in these Receivership Proceedings (case no. 8:09-cv-0087 only). I included time spent on the tasks outlined in Paragraph 5 above and detailed in the motion; and I excluded other time, as appropriate. As a result of my review, I certify that Exhibit A is appropriately limited and does not include attorneys' fees and costs incurred in efforts like defending Wells Fargo in the related litigation, pursuing Wells Fargo's motion for disqualification of the Receiver, or litigating the two Eleventh Circuit appeals.

11. The attorney and professional fees incurred in this matter total \$585,830.50.

12. The hourly rates charged and the hours expended by professionals are as follows:

13. The hourly rates in the table above are the blended rates charged by each professional during the more than six years that Akerman has been involved in this matter. In some cases, a professional's hourly rate might have changed during the course of his or her involvement in this matter, as permitted by the terms of Akerman's engagement letter and as agreed with Wells Fargo during the course of the relationship.

14. The attorneys' fees and costs described in Exhibit A were billed by Akerman and have been paid or are due to be paid, with two exceptions. First, as reflected throughout Exhibit A, Akerman routinely extends a "courtesy discount" to Wells Fargo, in an amount determined by the billing attorney on the file, in cooperation with the client. In this case, the courtesy discount equals \$64,764.01. Second, after receiving invoices from Akerman, Wells Fargo occasionally requests additional adjustments. In this case, these agreed-upon client adjustments equal \$34,059.49 – *i.e.* \$30,030.32 in fees and \$4,029.17 in costs.

15. After applying the courtesy discount and the client adjustments, the amount of attorney and professional fees requested is \$491,036.17 (the "**Requested Fees**").

16. In addition to the Requested Fees, Wells Fargo incurred \$20,541.10 in costs during the relevant period. After applying the client adjustment, \$16,511.93 (the "**Requested Costs**") should be taxed against the Receivership Estate, for the same reasons as the Requested Fees.

17. In addition, Wells Fargo can reasonably be expected to incur future attorneys' fees in this matter that will amount to approximately \$20,000 (the "**Estimated Future Fees**").

18. In addition to the Requested Fees, Requested Costs, and Estimated Future Fees, Wells Fargo incurred and the Eleventh Circuit awarded \$761.70 in Appellate Costs, which should be taxed against the Receivership Estate (the "**Appellate Costs**"). *See* Dkt. 1282, p. 3.

19. In addition to the Requested Fees, Requested Costs, Estimated Future Fees, and Appellate Costs, Wells Fargo incurred and the United States District Court for the Middle District of Florida awarded \$40,312.94 in costs which should be taxed against the Receivership Estate (the "**Related Litigation Cost Award**"). *See* Case No. 8:12-cv-557, Dkt. 340.

20. Finally, as further evidence of the reasonableness of this request, it should be noted that the actual value of the time spent by Wells Fargo's attorneys on these Receivership Proceedings was \$898,447.50. After reviewing the invoices, reducing time entries that were not pertinent to the issues in the motion, applying the courtesy discount, and applying the client adjustments, the attorneys' fees incurred by Wells Fargo and sought as an administrative expense herein equal \$491,036.17.

21. I have read the above statement, and the attached Exhibit A, and state that the statement and attached exhibit are true and correct to the best of my knowledge.






