## MOTION TO WITHDRAW

BUSH ROSS, P.A., Edward O. Savitz, Esq., Anne-Leigh Gaylord Moe, Esq., and Karen S. Cox, Esq. (hereinafter, collectively "Bush Ross") move this Court for leave to withdraw as counsel for non-parties Donald H. Rowe, Joyce A. Rowe, Carnegie Asset Management, Inc., and Wall Street Digest, Inc. (hereinafter, collectively "the Rowe Non-Parties"), pursuant to Local Rule 2.03, and state:

1. The relationship between Bush Ross and the Rowe Non-Parties has become irretrievably broken such that Bush Ross is unable to further represent the Rowe Non-Parties in this matter.
2. Withdrawal is proper under Local Rule 2.03 and Rule 4.1.16(b) of the Rules Regulating the Florida Bar.
3. Bush Ross notified the Rowe Non-Parties of its intent to withdraw on December 6, 2010.
4. Bush Ross has notified counsel for receiver Burton Wiand its intent to withdraw.
5. The Rowe Non-Parties will likely require additional time to retain new counsel to represent them in this matter. A stay of thirty (30) days is expected to be sufficient to allow them to retain new counsel and for such counsel to file a notice of appearance with this Court.
6. This motion is not being filed for the purpose of delay.

WHEREFORE, Bush Ross respectfully requests that within ten (10) days of the date of this filing this Honorable Court enter an Order granting Bush Ross, P.A., Edward O. Savitz, Esq., Anne-Leigh Gaylord Moe, Esq., and Karen S. Cox, Esq. leave to withdraw as counsel for the Rowe Non-Parties, ordering that Bush Ross, P.A., Edward O. Savitz, Esq., Anne-Leigh Gaylord Moe, Esq., and Karen S. Cox, Esq. are no longer counsel of record for the Rowe NonParties in this matter, and staying this case for a period of thirty days to allow the Rowe NonParties to retain new counsel.
