**NOTICE THAT RECEIVER HAS PROVIDED NOTICE  
OF APPROVAL OF RECEIVER'S CLAIMS DETERMINATION MOTION**

On December 7, 2011, Burton W. Wiand, as Receiver (the “**Receiver**”), filed his Unopposed Motion To (1) Approve Determination And Priority Of Claims, (2) Pool Receivership Assets And Liabilities, (3) Approve Plan Of Distribution, And (4) Establish Objection Procedure (Doc. 675) (the “**Claims Determination Motion**”). On March 2, 2012, the Court entered an Order (Doc. 776) (the “**Order**”) approving the Receiver’s Claims Determination Motion with respect to all claims submitted as part of the claims process

except for one claim submitted by Wells Fargo Bank, N.A. In the Order, the Court specifically approved the Receiver's Proposed Objection Procedure as detailed in Section V of the Claims Determination Motion, which required the Receiver to provide notice of the Order to claimants. This procedure included (1) posting a copy of the Order to the Receivership website at [www.nadelreceivership.com](http://www.nadelreceivership.com) within three (3) business days of the date of the Order, and (2) mailing letters to claimants by United States First Class Mail within ten (10) days of the date of the Order. This Notice is being filed to inform the Court that the Order was posted to the Receivership website on March 2, 2012, and that letters to claimants were deposited with the United States Postal Service on March 8, 2012 for delivery by U.S. First Class Mail.<sup>1</sup>
