LIMITED POWER OF ATTORNEY
(Conveyance of Assets)

KNOW ALL MEN BY THESE PRESENTS

THAT I, **CHRISTOPHER D. MOODY** of the County of Sarasota, State of Florida, referred to herein as PRINCIPAL, does hereby make, constitute and appoint **BURTON W. WIAND**, as Receiver in the matter of *Securities and Exchange Commission v. Arthur Nadel et al.*, Case No: 8:09-cv-87-T-26TBM, appointed by the United States District Court for the Middle District of Florida, Tampa Division, of the County of Hillsborough, State of Florida, to be my lawful attorney in fact and my agent (hereinafter called "AGENT") for the purposes described herein.

Third parties may rely upon the representations of my agent as to all matters relating to any power granted to my agent, and no person who may act in reliance upon the representations of my agent shall incur any liability to me or to my estate, beneficiaries, or joint owners as a result of permitting my agent to exercise any power prior to receipt of written notice of revocation, suspension, notice of a petition to determine incapacity, partial or complete termination, or my death. Any third party may rely on a duly executed counterpart of this instrument, or a copy certified by my agent to be a true copy of the original hereof, as fully and completely as if such third party had received the original of this instrument.

This Limited Power of Attorney shall not be affected by disability of the principal.

This Limited Power of Attorney shall automatically expire by its own terms upon completion of the purposes set forth above.

This Limited Power of Attorney, or a copy hereof, may be recorded in the office of any court clerk or governmental agency without further action on the part of the undersigned Principal.
