**PLAINTIFF'S RESPONSE TO DEFENDANTS'  
OBJECTION TO INCLUDING EVELYN HUGHES  
IN THE LIST OF PLAINTIFFS SCHEDULED FOR  
DEPOSITION IN SEPTEMBER**

**TO THE HONORABLE COURT:**

**COMES NOW** Plaintiff, in the above-styled and numbered case, and files this Response in Opposition to Defendants' Objection to including Evelyn Hughes in the List of Plaintiffs Scheduled for Deposition in September. For the following reasons, Defendants' Objection should be DENIED:

1. Plaintiff's counsel opposes Defendant's Objection because a completed Plaintiff Fact Sheet ("PFS") with Authorizations for Evelyn Hughes were served upon the Defendants on January 21, 2007.
2. Plaintiff's counsel subsequently received a deficiency letter stating that Defendants had not received Evelyn Hughes' Plaintiff Fact Sheet, nor Authorizations.
