ORDER ADOPTING REPORT AND RECOMMENDATION

This cause is before the Court on the report and recommendation (R&R) issued by Magistrate Judge Mark A. Pizzo on December 8, 2014 (Doc. 25). The magistrate judge recommended that the decision of the Commissioner be affirmed.

STANDARD OF REVIEW

When a party makes a timely and specific objection to a finding of fact in the report and recommendation, the district court should make a <u>de novo</u> review of the record with respect to that factual issue. 28 U.S.C. § 636(b)(1); <u>U.S. v. Raddatz</u>, 447 U.S. 667 (1980); <u>Jeffrey S. v. State Board of Education of State of Georgia</u>, 896 f.2d 507 (11th Cir. 1990). However, when no timely and specific objections are filed, case law indicates that the court should review the findings using a clearly erroneous standard. <u>Gropp v. United Airlines</u>, <u>Inc.</u>, 817 F.Supp. 1558, 1562 (M.D. Fla. 1993). No timely objections were filed. The Court has reviewed the report and recommendation and made an independent review of the record. Upon due consideration, the Court concurs with the report and recommendation. Accordingly, it is

ORDERED that the report and recommendation (Doc. 25) be **adopted** and **incorporated by reference**; the decision of the Commissioner be **affirmed**; and the Clerk of Court is **directed** enter judgment for the defendant and against the plaintiff and to close this case.
