**PET SUPERMARKET'S NOTICE OF ATTORNEY
NO LONGER ASSOCIATED WITH FIRM**

Defendant Pet Supermarket, through its counsel KUBICKI DRAPER P.A., serves notice that attorney Cassidy Yen Dang, Florida Bar No. 16482, is no longer associated with KUBICKI DRAPER PA and is now associated with the law firm of COLE, SCOTT & KISSANE, PA. COLE SCOTT & KISSANE is not counsel for Pet Supermarket in this action.

There appears to be no authorized motion or recognized procedure for an attorney to be removed from the CM/ECF list when he or she leaves one firm, associates with a different firm and is no longer counsel for a party. The CM/ECF website "Frequently Asked Questions" reveals the following:

Q: What should we do when an attorney leaves the firm?

A: When an attorney leaves a firm, both the attorney and the firm need to consider the implications to the CM/ECF noticing system. If cases will move with the attorney, the attorney needs to change his/her e-mail notification set up and submit a change of address to the Clerk's Office. If cases will remain with the firm, the firm will need to ensure that the Court docket accurately reflects the proper attorney of record and that the new attorney of record is properly set up to receive e-mail

notification. Law firms may also wish to consider the best method of handling e-mail addressed to the firm for the departed attorney. Summarily removing the attorney from the firm's e-mail system with no further action may result in notifications being missed. Firms may wish to consider whether their own e-mail systems should forward such e-mails to the attorney at his/her new address, or to another attorney within the firm.

This Notice seeks no substantive relief, but is filed to clarify to the Court, the Clerk of Court, the parties, and any person who receives electronic notice that neither Ms. Dang nor the firm of COLE, SCOTT & KISSANE is counsel for Pet Supermarket in this action. If there is a way to modify the CM/ECF list to so reflect, Pet Supermarket respectfully requests that it be done.
