**PLAINTIFF'S TENTH RESPONSE TO THE COURT'S
SHOW CAUSE ORDER**

COMES NOW plaintiff, John B. Thompson, hereinafter Thompson, as an attorney on his own behalf, and further responds to this court's September 24, 2007, Order to Show Cause and states:

1. As already pointed out to this court, SLAPP Bar complaint Norm Kent panicked and removed from his www.nationalgaynews.com porn portal linked to from his official law firm site at www.normkent.com all offerings of "Adult Sites." Mr. Kent, even in his state, understood that he was at risk.

2. The undersigned retained experts in such things to do screen captures proving Kent's removal of this material.

3. However, now that Mr. Kent thinks "the coast is clear" by virtue of his and other's use of this court's Show Cause Order to alleged that the undersigned is "trafficking in obscenity" an in light of the fact that someone apparently got through to Mr. Kent that his removal of what he calls the "Porn Sites" from his web pages was in fact an admission of wrongdoing, Mr. Kent has now put up at his site not just the

previously displayed “Porn Sites, “ including the clearly “obscene” (this court’s word) www.justusboys.com but also, this morning EVEN MORE “PORN SITES.” Note:

Note that Mr. Kent now says, which is something new on the site, that he **“has no control over the contents therein.”** Ahhh, but he does have control over whether or not he disseminates this material to anyone, including children. Mr. Kent’s suggestion, which only a desperate lawyer could come up with, that he is somehow not culpable for what he is disseminating willy-nilly is akin to the murder defense of the fellow who points a loaded gun at a crowd and fires away, claiming he had no “intent to commit murder” because he had no intent to hit any single person. This is legal nonsense that a criminal jury would find laughable. It may be that Mr. Kent “has no control,” but not in a legal sense. There are experts in other areas of specialty who can explain how “he has no control” over what he does.

4. The undersigned respectfully requests that this court do two things:
 - a. Vacate its improper Order to Show Cause;

b. Prove how even-handed it is in its concern for “children,” and provide notice to the parties herein that this court has formally asked the Honorable Alex Acosta, U.S. Attorney for the Southern District of Florida, to proceed against Mr. Kent for his dissemination of “obscene” (the court’s term) material. What Mr. Kent, and more importantly this court, knows is that the distribution of “obscene” material is a criminal act. What Mr. Kent is doing is clearly in violation of state and federal laws, not to mention his sully of the “dignity of our profession” as the Florida Supreme Court puts it.

5. If the court is going to act on its alleged concern about “children” in threatening Thompson, then it should discharge its clear duties, as a member of the federal court system, to give full force and effect to the enforcement of federal laws dealing with the illegal trafficking, for commercial gain, in “obscenity.” Take a look today at what Mr. Kent is offering at www.justusboys.com right now. If I know what is there, Mr. Kent knows what is there, and the court would do well, since it wants no pictures, to certify to the parties herein THAT THIS COURT HAS GONE TO WWW.JUSTUSBOYS.COM and confirmed what is there this day.

6. Thompson would appreciate word from the court prior to October 5 that it has done all three of these necessary and proper acts.
