**PLAINTIFF'S VERIFIED ADDENDUM TO MOTION TO
RECUSE/DISQUALIFY JUDGE ADALBERTO JORDAN**

COMES NOW plaintiff, John B. Thompson, as an attorney on his own behalf, and moves this court to disqualify himself from further presiding in this cause, stating:

Plaintiff is not sure he can imagine more stunning proof of not only the impropriety but the cool calculation of this court's threatening him with discipline by the "Ad Hoc Committee" than what he now has in his hands. It serves as well to prove precisely why this court *must* recuse itself. Please note:

Thompson e-mailed Tom Meeks, Vice Chair of the *Ad Hoc* Committee and asked him for a current list of members on the Committee. Thompson has referred, for the sake of convenience, to The Club which describes the "in crowd" of the legal community here. This court knows Thompson is not going to get a "fair" shake from the following individuals on the *Ad Hoc* Committee that is going to assess Thompson's actions in a case against The Florida Bar of all entities:

Jackie Bécerra: She's a Miami partner of Barry Richard in Greenberg Traurig
Barry Richard represents The Florida Bar in this action!

John (Jack) Brumbaugh: Besides having a fabulous great first name and nick name, this guy is partner to John G. White, the President Elect of The Florida Bar!

Kelly Ann Cartwright: Partner to Florida Bar Governor Larry Sellers at Holland and Knight!

Manuel Garcia-Linares: Managing partner at Richman Greer and partner to President of The Florida Bar, John White (see Brumbaugh above)!

Alice Hector: Partner to gay rights advocate and Bar Governor Steven Chaykin at Akerman Senterfitt! Chaykin is my “designated reviewer” who formally recommended that I must submit to a mental exam yet again!

Marilyn Holifield: Partner to Bar Governor Larry Sellers at Holland and Knight!

Judith Korchin: Partner at Holland and Knight to Bar Governor Larry Sellers!

Mark Schnapp: Miami partner at GreenbergTraurig to Barry Richard, The Florida Bar’s attorney in this case (see also Jackie Becerra above)!

Melinda Thornton: Assistant State Attorney in the office of Kathy Rundle whose office has gone out of its way, repeatedly, to show it never forgave me for running against the Queen Bee of Political Correctness, Janet Reno!

Alex Acosta: U. S. Attorney, the man who ordered the FBI to drop an investigation of The Florida Bar for its civil rights violations against Thompson, plaintiff herein!

Jacqueline Arango: Assistant U.S. Attorney in Acosta’s office!

Plaintiff respectfully asks this court: **You have got to be kidding.**

Not a single one of these people wouldn’t be removed for cause as jurors in a case involving Thompson.

This court is insisting that a any person would “reasonably” conclude that it is impartial in its judgments, its actions, and its attitudes against Thompson, when this court has turned him over to this crowd? Thompson had no idea when he referred to The Club in his Fourth Amended Complaint that it was *this* bad.

To make matters worse, Thompson has just received e-mail confirmation from the *Ad Hoc* Committee’s Meeks that they have no authority to do anything. Nothing. All they can do is make recommendations to Judge Jordan as to what *he* should do to discipline Thompson.

So what this court did was make a very big public display of how naughty it was of Thompson to present to this court evidence of The Bar’s duplicity and double standard and selective prosecution by sending him over to this Committee. This court knew full well that it, **and it alone**, had the power to do something, by way of discipline, to Thompson. What this court has done is send it to “Ad Hoc” in order to appear to wash its hands of what it will eventually do, so that it is not this court that comes up with the punishment. The court has tried to wipe its fingerprints from the murder weapon.

This is precisely what Pilate did when he asked of the crowd “Whom shall I give you? Jesus or Barabbas?”

What this court has done is further proof that it is not a fair arbiter in this case. This is one of the most sickening things he has seen any court do in 31 years of practicing law. This court ought to be impeached for this.

Finally, and this is a remarkably sweet but not surprising finding: Thompson has confirmed today from the United States Government Accounting Office that the United

States Government is statutorily authorized under Title 5, Chapter 57 to reimburse all Bar dues and fees to sitting federal judges. What does that mean?

That means that this court's friend, U.S. District Court Judge Paul Huck, when he recused himself from the case filed by the SLAPP-Jack Thompson law firm of Tew Cardenas against The Florida Bar, citing and claiming his legal obligation to have to pay, out of his own pocket, his Bar dues and fees as the basis for having a "financial interest" in that case that disqualified him from it *had no idea what the heck he was talking about*.

This court, now trading on that falsehood, refuses to recuse itself from this case, despite its affiliation with The Florida Bar far stronger than having to pay dues, because, Judge Jordan says, no money is at stake. There is no money at stake in the Huck case, Judge.

None of the people arrogating unto themselves the self-righteous notion that they should sit in judgment of Thompson has the right to sit in judgment of anyone.

The above is proof of hubris, mendacity, and hypocrisy like Thompson has never seen.

This is precisely why the ABA's McKay report strictly warns that people who have some interest in Bar discipline must have nothing to do with it—like Bar Governors. Judge, disqualify yourself. This is beyond absurd.
