Re: U. S. District Court Judge Adalberto Jordan

Dear Judge Moreno:

The above Judge, who heretofore has enjoyed a fine reputation as a good judge, has gotten himself into a pickle with an ill-advised and baseless "show cause order" entered last week because I dared bring him the evidence of The Florida Bar's selective prosecution of me, which is a key issue in my federal civil rights action, Case No. 07-21256. The evidence is also proof of "obscenity" trafficking with the cooperation of The Florida Bar. As Justice Potter Stewart would suggest, you have to see it to believe it, not only as to the obscenity but as to Judge Jordan's remarkable, unseemly, outrageous and baseless response.

Judge Jordan fabricated facts and fabricated law to come up with his utterly contrived show cause order. I know full well the risk I run in saying such a thing. It is the truth. When I proved how improper Judge Jordan's order was, Judge Jordan apparently panicked and closed the "show cause window" that he had ordered to be open until October 5 by violating his own order and referring me to the "Ad Hoc Committee," whose members you appoint, on October 2.

So thoroughly has Judge Jordan proven himself to be utterly incapable of impartiality in this case that no person could "reasonably," in the words of the disqualification statute, not think that Judge Jordan had disqualified himself by his antics. I have asked him to recuse himself. He refuses, even though he has decided not to be a mere decision-maker in the process but a participant in The Bar's unconstitutional assault upon my First Amendment rights. Judge Jordan has gone from jurist to tortfeasor. His show cause order did that, and then his crawfishing to cover his tracks has made it even worse.

It is not irrelevant to point out that the Third District Court of Appeals just whacked Miami-Dade Circuit Court Judge Ronald Friedman for intemperate behavior that pales in comparison with what Judge Jordan has done in Case No. 07-21256, only a small portion of which is related herein. Look at the court file and note how Judge Jordan has gone out of his way *in orders* to attack me personally. Look at the various orders regarding the show cause issue that contradict one another on their face.

I have never had a judge make up facts and then once the facts were refuted claim in a subsequent order that he did not assert those facts. This is a judge in full flight from his duties as a citizen, let alone his duties as a federal judge. I have never seen such a thing by any judge at any level. I have no problem with judges making mistakes. This is not that. This is a federal judge engaging in unethical activity that calls into question his fitness to continue as a judge presiding over *any* case.

We now have a hearing not only on the show cause order but also on the defendants' motions to dismiss tomorrow morning. This judge can rule on none of them, so thoroughly has he insinuated himself personally into this case.

Eleven of thirty-two members of the *Ad Hoc* Committee are so compromised that if these eleven composed a jury pool in any case of any kind involving me they would have to be excused *for cause*.

Please note who these eleven are, whose identities and affiliations are fully known to Judge Jordan and have been for days:

Jackie Becerra: She's a Miami partner of Barry Richard in Greenberg Traurig Barry Richard represents The Florida Bar in this action.

John (Jack) Brumbaugh: This fellow is partner to John G. White, the President Elect of The Florida Bar.

Kelly Ann Cartwright: Partner to Florida Bar Governor Larry Sellers at Holland and Knight.

Manuel Garcia-Linares: Managing partner at Richman Greer and partner to President of The Florida Bar, John White (see Brumbaugh above).

Alice Hector: Partner to gay rights advocate and Bar Governor Steven Chaykin at Akerman Senterfitt! Chaykin is my "designated reviewer" who formally recommended that I must submit to a mental exam yet again.

Marilyn Holifield: Partner to Bar Governor Larry Sellers at Holland and Knight.

Judith Korchin: Partner at Holland and Knight to Bar Governor Larry Sellers.

Mark Schnapp: Miami partner at Greenberg Traurig to Barry Richard, The Florida Bar's attorney in this case (see also Jackie Becerra above).

Melinda Thornton: Assistant State Attorney in the office of Kathy Rundle whose office has gone out of its way, repeatedly, to show it never forgave me for running against the Queen Bee of Political Correctness, Janet Reno.

Alex Acosta: U. S. Attorney, the man who ordered the FBI to drop an investigation of The Florida Bar for its civil rights violations against Thompson, plaintiff herein.

Jacqueline Arango: Assistant U.S. Attorney in Acosta's office.

My federal lawsuit alleges that Steve Chaykin has engaged in illegal activities in violation of federal law, which gives rise to federal civil rights remedies against The Bar. As you see from the above, Chaykin's partner is now on this Committee, per your order.

No fair and impartial federal judge would have entered such a show cause order based upon what Judge Jordan knew to be the law and the "facts" that we now know did not exist. Beyond that, no federal judge with any real judgment, knowing the composition of this *Ad Hoc* Committee would have failed to vacate his show cause order by now, given the Committee's composition and the baseless of the order having now been proven. Finally, no fair federal judge in his right mind would possibly preside over a hearing tomorrow morning when his decision-making largely turns upon whether this same judge has acted fairly and properly. This judge thinks a judge can judge himself. He cannot. No judge can.

This judge is supposed to be above suspicion in all things. If he doesn't "get that," then the Chief Judge should surely get that.

You have the authority to pull this judge off this case, immediately. You must do so.

If you want me to appear before you before the improper 9:30 am hearing, then I shall do so. I can attest to all of the above under oath.
