**PLAINTIFF'S REQUEST/MOTION  
THAT THE COURT TAKE JUDICIAL NOTICE**

COMES NOW plaintiff, John B. Thompson, hereinafter Thompson, as an attorney on his own behalf, and moves this court to take judicial notice of the facts in the attached letter, stating:

Additional proof of The Bar's bad faith, which The Bar improperly asserts Thompson cannot possibly have, is The Bar's pursuit of its baseless and fatally *unsworn* SLAPP bar complaint filed by the always interesting Judge Ronald Friedman.

Thompson hereby asserts that everything in this letter is true, as indicated by the verification, below.
