PLAINTIFF'S NOTICE TO THE COURT OF CRIMINAL A) WITNESS TAMPERING, B) EXTORTION, C) OBSTRUCTION OF JUSTICE, D) RETALIATION, AND E) CONSPIRACY BY THE FLORIDA BAR AND DEMAND FOR A HEARING

COMES NOW plaintiff, John B. Thompson, hereinafter Thompson, as an attorney on his own behalf, and provides notice to the court as follows:

Within the last two weeks, plaintiff informed this court that The Florida Bar sought to intimidate a witness, Miles Gopman. Upon the court's being informed of this, the court did absolutely nothing. It denied Thompson a hearing on his motion to show cause, although this court was lightning quick to refer Thompson to the *Ad Hoc* Committee for reasons too familiar and too ridiculous to reiterate.
