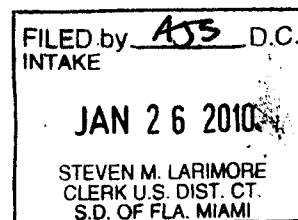

COMES NOW plaintiff, John B. Thompson, hereinafter Thompson, on his own behalf, and notifies the court of the following:



What we have here, on your watch, is the altering of a federal court file for the purpose of ridiculing me. It is just the latest example of the animosity you yourself and thus the rest of this District Court have engaged in to my detriment. You know what you have done in violation of the law. I don't need to recount it all.

I am demanding, Judge Moreno, that you, as Chief Judge of this District Court, find out who criminally altered this federal court record in this fashion, deal with whomever did that, and *tell me* post haste what you have done in that regard.

Further, if this court does not get to the bottom of this and do something about it and tell me what it has done, then the Eleventh Circuit Court of Appeal will do your job for you, and you won't like the judicial consequences that follow. This Court's violation of my civil rights, at your behest, has gone on quite long enough. The attached items prove it.
