**PLAINTIFF'S VERIFIED MOTION FOR RECONSIDERATION FOR RELIEF
FROM ORDER DISMISSING THIS ACTION AND MEMORANDUM OF LAW**

COMES NOW plaintiff, John B. Thompson, hereinafter Thompson, on his own behalf, and moves this court for reconsideration of his Rule 60 motion for relief from its order dismissing this action without prejudice, stating:

1. This court asserts in its September 7 order denying the relief sought that, "Mr. Thompson provides no evidence that Judge Tunis was not chosen based on the alphabetic [*sic*] order of the referees." Thompson presumed, apparently wrongly, that this court would, upon learning of this fraud by the defendants, want an evidentiary hearing as to the motion. This court has time in its busy schedule to hold forth, ironically, on October 1 in the fancy Bankers Club on the topic of "Ethics and Professionalism":

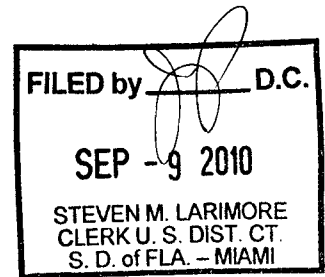

2. So, since this court indicated there is no proof of fraud, here is the proof, offered under oath by way of this verified pleading, as Thompson can best, with his limited resources, proffer it. Let the defendants come forward with their sworn refutations or explanations of the follow if they like as to this evidence:

3. All of the below-described and attached documents were provided by the Office of the Chief Judge of the Eleventh Circuit Joel Brown. It can thus be presumed that they are accurate. Attached hereto as Exhibit A is the January 25, 2007, order, entered by then Chief Judge Farina, appointing Judge Saenz to serve as a bar referee.

4. The next referee appointment order, taken in chronological order, provided by Chief Judge Joel Brown, was Exhibit B, by which Judge Farina appointed Dava Tunis to serve as bar referee in *Bar v. Thompson*, on February 6, 2007. There were two other appointment orders entered between the dates of the Saenz and Tunis orders. However, these judicial appointments were taken out of alphabetical order, apparently for good reason. Judge Edward Newman was appointed on January 25, 2007, to serve as a bar referee in *Bar v. Bitterman*. He was chosen because he had served in that capacity in a related matter pertaining to *Bitterman* in 2003 and 2004. He had knowledge of the case.

5. Similarly, Judge Celeste Muir was appointed also on January 25, 2007—the same day that Judge Saenz (see above) was appointed by Farina, in *Bar v. Moore*, but that non-alphabetical appointment is explained, as is the Newman appointment, by the fact that Muir had served as referee in a related matter pertaining to *Moore* in 2006.

6. So, the deviation from the alphabetical appointments is explicable as to Newman and Muir. The two referee appointments that matter for purposes of this analysis, then, are Saenz and Tunis. This federal district court will recall that it already

has the document, attached as an exhibit to an earlier filing, by which the Chief Judge's Office itself claims that referees, by virtue of a long-standing practice, are chosen alphabetically. The explanation is categorical. It would be comprehensible even to a Bar Governor.

7. When Thompson asked, by means of his public records request, for these appointment orders, he also asked for the Chief Judge's formal listing of all judges in this Eleventh Judicial Circuit, from 2003 to present. Attached as composite Exhibit C are the "Judicial Court Directories" that bracket the Saenz and Tunis appointment orders: January 17, 2007; January 26, 2007; and February 9, 2007.

8. Unless Thompson lost his understanding of the alphabet learned in his first grade class in 1957, here are the judges that fell between Saenz and Tunis who should have been appointed, by Judge Farina, if the appointments really were alphabetical as claimed:

9. The above names are those of TWENTY-TWO (22) JUDGES that fall, alphabetically, between Saenz and Tunis. Maybe some of them or their spouses were being treated for cancer when their “letter” came up and they couldn’t serve. Maybe some had other reasons why they were not appointed by Judge Farina. Given this huge number of judges, plaintiff is entitled, before this court facilely writes off his legal career, to some sort of explanation from The Bar, the Chief Judge, the Florida Supreme Court—from SOMEBODY—as to why all twenty-two were apparently leapfrogged in order to cherry-pick Dava Tunis. Maybe they have an explanation. Maybe Thompson is wrong. He was wrong to think he could get a fair hearing from a federal court, but let’s hear from these smartest people in the room why all twenty-two judges were not available.

10. So there’s the proof that Thompson has so far, along with what he sent the court yesterday—that Dava Tunis hid her labors within The Bar’s disciplinary machine, *which she was formally asked about*—in order to avoid having to disqualify herself.

11. When you couple that and the above with the fact that Dava Tunis accepted money from Thompson’s two designated reviewers—Ben Kuehne and Steve Chaykin (his firm) and his Miami Bar Office Prosecutor Barnaby Min—*after* she was assigned the

case, one wonders what one has to do to raise cause just one eyebrow of this Honorable Court to rise with the faintest concern that a bunch of self-righteous bureaucrats might have done something wrong here. U.S. Supreme Court Justices Black and Douglas saw such a danger coming from integrated state bars and said so in *Lathrop v. Donohue*. Yet this district court's perspective, it seems, is that Black and Douglas were nettlesome troublemakers just like Thompson.

12. This federal district court, in its September 7 order, actually says: *“Even if Judge Tunis was not chosen based on the alphabetic [sic] order of her name, that information alone would not make the Bar’s statement that she was impartial fraudulent, or suggest that the method by which she was chosen was so outrageous that omission of this information from the original record is an extraordinary circumstance.”*

13. Let’s get this straight. This court is saying that even if the procedure for choosing a referee was violated because it was Thompson who was the respondent, then this does not, even in the slightest, suggest that fraud might have occurred and that concern as to why Tunis was improperly cherry-picked should not exist. Really?

14. Plaintiff has already provided to this court the federal case that holds that when a tribunal is chosen *not* at random and when it can be shown that that tribunal acted in such a fashion as to prejudice a litigant, then grave doubts about a deprivation of due process arise. See *Francolino v. Kuhlman*, 365 F.3d 137 (2nd Cir. 2004).

15. Did Tunis act in a fashion prejudicial to Thompson. Tunis denied Thompson discovery during his case. She allowed him no evidence to be entered at trial. She ruled on not a single constitutional defense he raised. She recommended a punishment that does not even exist in Florida. She was provided proof that the Bar prosecutor submitted

to her a perjured costs affidavit, and she ignored even that. What about the word “prejudicial” is not clear, under the *Francolino* analysis?

16. Tunis was, in violation of this circuit’s own rules, chosen to be Thompson’s referee. She then stuck it to him every single way she could. She refused to comply with Florida law in disclosing her relationships with The Bar’s disciplinary machinery and its personnel. If this is not fraud, then what, pray tell, does fraud look like?

17. With all respect for this Article III court, and in fact *because* Thompson respects this court and how it is supposed to discharge its oath, it appears to Thompson that the working premise of this Honorable Court is that if Thompson comes forward with facts, they are not to be treated even as plausible allegations because to do so opens the door to federal judicial relief for Thompson. This court, like The Bar, maybe even for the best of intentions—maybe to purge the judicial system of culture crusaders, as this court and Dava Tunis both smeared him—has refused to consider Thompson’s right to be heard.

18. How many seminars on “Ethics and Professionalism” would this court be asked to participate in if this court, Heaven forbid, were to be the one identified as the one who let the “lunatic lawyer from Miami” prove his case.

19. This court suggested there is no proof of cherry-picking. It now has it. It has the *Francolino* case, and Thompson didn’t even have to go to Alaska case reporters to find it. This court is left with its own statement, then, that even if Thompson’s Bar referee was improperly chosen, then the presumption SHALL be that that fraud does not give rise to concerns about impartiality.

20. This court's assertion is absurd. And here's the proof: If it became known that the Chief Judge of this District Court was going around the computer-driven, random selection of judges and was in fact pairing judges with certain litigants in order to help assure certain results, then that Chief Judge would be impeached and then convicted, criminally, of honest services *fraud*.


21. That is precisely what happened in the state court system, and, so far, this court can't be bothered. It must allow itself to be bothered, whether it thinks Thompson is a jerk or not, and he most assuredly, the plaintiff will stipulate, is.

22. Finally, Thompson is strident in his tone. Who wouldn't be, given what these people—these self-proclaimed “Guardians of Democracy”—have done to him and how they have done it. Thompson doesn't want this court's sympathy, its understanding, or even any modicum of respect. What he demands is that this court adhere to its oath and do justice as to “Ethics and Professionalism” rather than just doing seminars on those topics.

WHEREFORE, plaintiff moves this court to vacate its dismissal order so that he might have the opportunity to prove, because of patent fraud, that The Bar proceedings against him were rigged by the improper selection of Dava Tunis in order to deliver Thompson's head to The Bar on a silver platter purchased by the porn industry.


