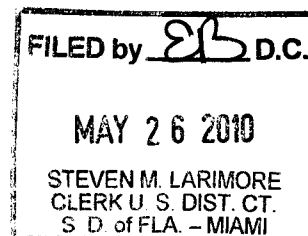

**PLAINTIFFS' MOTION TO EXCEED PAGE LIMIT IN RESPONDING TO  
DEFENDANT AMAZON.COM, INC.'S "MOTION TO DISMISS FOR IMPROPER  
VENUE OR, ALTERNATIVELY, MOTION TO TRANSFER VENUE OR,  
ALTERNATIVELY, MOTION TO DISMISS FOR FAILURE TO STATE A CLAIM"**

Plaintiffs, Albert Segal and Marianna Chaparova (hereinafter "Plaintiffs"), on their own behalf, move to submit the following Motion to Exceed Page Limit, seeking permission from this Court to file and serve their Memorandum of Law in Opposition to Defendant Amazon.com, Inc.'s Motion of May 17, 2010, in excess of ten (10) pages, pursuant to Local Rule of Civil Procedure 7.1, and so aver:


6. Plaintiffs' estimate of the length of their Memorandum of Law in Opposition to Amazon's Motion is not expected to exceed twenty (20) pages.




