Dear Ms. Chaparova and Messrs. Segal and Esau:

This is to confirm the *Scheduling* of the mediation session in the above styled case. My hourly rate will be \$350, payable in equal halves by each of the parties.

The scheduled mediation will take place at my office located at 111 Majorca Avenue, Coral Gables, FL 33134 on *Tuesday*, *February 15*, 2011, at 9:00 a.m. Please advise your clients to be on time in deference to all parties as charges begin at the time set for the session. If you have any specific time constraints, advise me immediately. By mutual request, <u>HALF DAY</u> has been set aside.

Payment in advance is to be made ten working days prior to the mediation, payable by each client or \$350 each. All cancellations less than ten working days before the mediation will be billed at my hourly rate, for a minimum of two hours, payable equally by both parties or \$350 each.

In addition, should there be any additional work or subsequent court appearance or other efforts of the mediator, including collection, the same hourly rate shall also apply for such time. Any additional time and resulting expense shall be borne equally by both parties. Please forward any pre-mediation statements, or in the alternative I would ask permission to speak with both attorneys briefly before the mediation. Unless I receive an objection, I shall assume this is acceptable to both of you.

If there are any special needs or accommodations (ADA) that need to be made, please advise me immediately.
