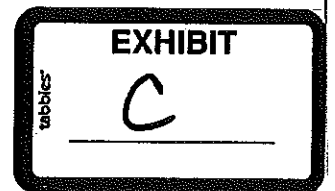

AFFIDAVIT OF GEORGE CROMPTON

BEFORE ME, the undersigned authority, on this day personally appeared George Crompton, who after being first duly sworn, under oath, deposes and says:

1. My name is George Crompton.
2. I am the Owner and President of Park Row Printing. Park Row Printing provides cellular telephones to its employees for business and personal use. As the Owner



and President of Park Row Printing, I make the decisions regarding the cellular telephones issued to and used by my employees.

3. In early November of 2010, my employee, David Rourke, came to me and told me that the Park Row Printing cellular telephone he had been issued was starting to break down. I told him to try to work through it. Mr. Rourke came back to me a few weeks later, and told me that the cellular telephone would not operate.

4. On November 30, 2010, I gave David Rourke the Blackberry Storm, which was not activated at that time, and which was not being used at that time by any of Park Row Printing's employees. I had not had or been advised of any issues regarding the operation of the Blackberry Storm prior to giving it to David Rourke.

5. In January of 2011, Howard Crompton came to me and advised me that he needed to give the Blackberry Storm to his attorneys.

6. On January 27, 2011, I took David Rourke to the Verizon Wireless store located at 6989 W. Broward Boulevard, Plantation, FL, 33317. I bought David Rourke a new Blackberry Bold 9650, and the store transferred the contact information in the Blackberry Storm to the new Blackberry Bold 9650. The Blackberry Storm was deactivated by the store employee. I told the store employee not to remove any information from the Blackberry Storm and to preserve it in the condition it was in. I left the store with the Blackberry Storm.


7. I have not used or been in possession of the Blackberry Storm since January 27, 2011.

8. At no time did I ever have a password for the Blackberry Storm or use a password for the Blackberry Storm. To the best of my knowledge there is no password for the Blackberry Storm.
