 I also spoke with Sherrill Kent who is fielding calls for the Sclawy-Adelmans. They are of course devastated and I understand Howard Adelman is not talking to anyone- not even his wife. I have funeral information and will go out in an email shortly. I also understand they have denied the autopsy request by the sheriff's office.
 I will call Howard Crompton this morning and see how he is doing. I am mentally exhausted so not planning too much today.
 I'll be in touch with you later in the day.

I tried to alert the professionals at Council to give them a chance to prepare for what is sure to come, front page news. Unfortunately none were listed in telephone books, cell phones have no room to leave messages and no one I spoke to had home phone numbers for any of them.
 I did speak with Greg Ramos and told him hoping he had numbers I did not. He only had Annette Hungler's and there was no room to leave a message. I tried paging her and still am awaiting a return call.

Your information is right on point and says what it needs to say. Hang in there and let me know if there is anything I can help you with. I would also not speak to any reporters until you have had a chance to speak with Jeff Hunt. He will hopefully give you and Howard some legal counsel.

It is with deep regret that I inform the troop family of some devastating news.

While on a troop hike Saturday on the Florida Trail in the Big Cypress Preserve, for completion of the 20 mile requirement, one of our older Life scouts, Michael Sclawy-Adleman developed symptoms of heat exhaustion/stroke and, while first aide measures were immediately begun, later died before reaching a medical facility.

Although only 5 miles from the Big Cypress Oasis Ranger Station, conditions for that trail allow for only a maximum 3 mph + travel time on foot and cell phone signal is unreliable. Scoutmaster Crompton stayed with Michael while I went for assistance and took the other two scouts in. As I reached the station, where there is also a National Park Service fire helicopter unit, a response team was already being assembled. (The Scoutmaster was able to get a signal and called 911 as Michael's condition had worsened in my absence) Although we were able to give responders GPS coordinates it was still difficult to locate them, land and transport him back to the station. The whole time line was painfully time consuming but what wilderness conditions dictate.

Details for funeral arrangements will be forthcoming.

Please keep Michael, his twin sister Elizabeth, his parents, Howard and Judith and their families and our Scoutmaster in your prayers.

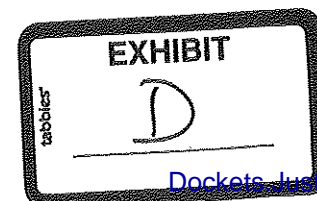
The other two First Class scouts, Chase Crompton and Khris Leon are fine.

This email is being sent to our immediate adult troop members only.

I apologize for the numerous emails but as developments occur I want to keep everyone informed.

First. The Troop Committee has authorize me to expend what ever funds are necessary to assit the Sclawy-Adelman's at this time. Traditional Jewish customs do not usually include flowers at funerals but the family has indicated they would accept and appreciate an arrangement from the troop. A live plant will also be sent from the PLC and scouts. Additional flower arrangements are discouraged but fruit baskets to the home are ok if so desired.

Second. If anyone would like to bring additional food or schedule food for later in the week please contact Sherrill. 954.295.7878 or 954.423.3788

Third. Although a school day, it would be appropriate for scouts to attend the service, in Class A. We would particularly expect the members of Michael's patrol to be in attendance. Attendance at the cemetery or home afterwards will be at your discretion. This is a difficult time and may not be easy for some of the scouts but the family will appreciate the showing of support and respect from his fellow troop members. If any scout needs transportation please contact me and I will make the arrangements with an adult leader.

Fourth. As of this time, there has been no designated organization for donations. Cards would be appropriate until we receive additional information.

Fifth. Clarification of visitation. Jewish tradition calls for a Shiva after the funeral. This is a time of healing for the family and rely's primarily on visitors eating and talking about Michael with the family. This time begins after the funeral (Tuesday afternoon) and continues until Friday night at 9 PM. You need only show up at their home, phone calls are discouraged. As most visits occur in the evening hours, you are encouraged to go during the day if that is possible. Visits after Friday should be preceded by a phone call.

And finally, news reports have and may appear over the next few days. Inaccuracies are inevitable so please rely on the Troop's information regarding what actually occurred. As reported in the SunSentinel and Channel 10 News, the hike was 20 miles, not 7.7, and there was NO water on or near the trail.

Andy,

I have never heard of or seen a Trek Safely Form. In fact I wasn't even aware of Trek Safely course. Will need to check that out. As many times as I have hiked the Florida Trail (most recently 2/07), I never did any more than you did, which is contacting the park service to check out conditions and file a back country tour permit, which many times was done and placed in the box before the ranger station opened. Tour permits are necessary whenever you are going outside of your normal area.

Andy, you need to know that the CYA gang will try to cover their ----- in an event that something doesn't go well. It would seem to me that you had given proper notice to everyone on the needs and preparation for the trek. Something tells me there may have been another latent cause of death that may have been exacerbated by heat exhaustion/stroke.

Jeff Hunt asked me if we had filed a Trek Safely form for the hike. I am unaware of this form and could not locate it on either the Council or National web sites. Are any of you aware of such a form? We did file the back country permit with the National Park Service at the start of the trail and had contacted the Park Service the day before to verify trail conditions.

I have completed the Trek Safely course. My course materials are in our files at the church so I will double check to see if there is mention of a form.

This is the contents of the email sent to the troop prior to the hike:

For those scouts that have been working on the hiking merit badge, we have scheduled a 20 mile hike for this Saturday. For those that have been participating in all the scheduled hikes to date, this is the final required hike.

Scouts need to bring: day pack with lunch, poncho, sunscreen, insect repellent, **3-4 quarts of water**, personal first aid kit, additional healthy snacks. **Wear:** good comfortable shoes, hat, Class B uniform.
