

Dear Mr. Peltz:

I am writing to you about the deposition of Carter Conrad, Jr., and our efforts to resolve the issues in the Motion for Protective Order. On Monday of this week, you called to discuss the issues, and I returned your phone call and we discussed the issues. At that time, we each agreed that you could ask Mr. Conrad fact questions and that the deposition could be continued for that purpose. We did not agree that the question stated in the Motion for Protective Order could be answered by Mr. Conrad, nor did we agree that Mr. Conrad could give expert opinions on behalf of Plaintiffs. However, we did agree that we should each receive and review the transcript and confer further.

Today, we discussed in the morning that we had each received the transcript and I needed time to read it. We have again conferred on the telephone, and my position remains the same. For the reasons stated on the record at the deposition, as well as in the Motion for Protective Order, my position remains that Mr. Conrad should not be compelled to answer the question you have certified, and should not be compelled to give expert opinion testimony on behalf of Plaintiffs.
