| 7  | Myers, does that indicate that the investigating officer    |
| 8  | believed that there were potential elements of criminal     |
| 9  | conduct that were involved in the death of Michael Adelman? |
| 10 | MR. KLEINMAN: Object to the form.                           |
| 11 | MR. SUMMERS: Objection to form.                             |

When Howard Adelman had contacted the park 14 ο. rangers several days after his son's death, was that in 15 part to provide information that you would use as part of 16 your normal investigation? 17 Well, had he not called us, we would have 18 reached out to him to obtain background information. 19 Okay, do you know whether someone had, in fact, 20 Q. called him first and he was returning a call? 21 No. I don't know. Α. 22 Okay, is that a possibility? 23 Q. It's possible. 24 Α. MR. SUMMERS: Objection to form. 25

| 15 | conversation of May 11th, you've indicated that Howard      |
| 16 | provided you some information that was used for your report |
| 17 | that he was sad. Was there anything else that went on       |
| 18 | during that call?   |
| 19 | A. This call?   |
| 20 | Q. Yes, sir.  |
| 21 | A. I don't recall anything else.                            |
| 22 | Q. Now, did - did any of the rangers, in this call          |
| 23 | - strike that. I guess it would have been you, so let me -  |
| 24 | let me rephrase the question. In this call that - that you  |
| 25 | have had with Howard on May 11th, did you provide any       |
