ORDER GRANTING DEFENDANTS', HOWARD K. CROMPTON AND ANDREW L. SCHMIDT, MOTION TO PRESERVE MATERIAL EVIDENCE AS TO MICHAEL ADELMAN'S CELL PHONE, HIS FAMILY'S CELL PHONES, AND CELL PHONE DOCUMENTS AND INFORMATION

THIS CAUSE is before the Court on Defendants', HOWARD K. CROMPTON and ANDREW L. SCHMIDT, Motion to Preserve Material Evidence as to Michael Adelman's Cell Phone, his Family's Cell Phones, and Cell Phone Documents and Information, and the Court having reviewed the Motion and being otherwise fully advised in the premises, it is hereby ORDERED and ADJUDGED that Defendants' Motion is GRANTED, as follows:

1. Plaintiffs shall disclose to the Defendants Michael Adelman's cellular telephone number. Plaintiffs shall disclose the name of the provider, the address of the

provider, and produce copies of any bills, ledgers, logs and/or correspondence, in Plaintiffs' possession, custody or control, relating to Michael Adelman's cellular telephone number.

- 2. Plaintiffs shall disclose to the Defendants all cellular telephone numbers of Howard Adelman (Michael's father), Judith Sclawy-Adelman (Michael's mother), and Elisabeth Sclawy-Adelman (Michael's sister). For each, number, Plaintiffs shall disclose the name(s) of the provider(s), the address of the provider(s), and produce copies of any bills, ledgers, logs and/or correspondence in their possession, custody or control, relating to these telephone numbers.
- 3. Plaintiffs shall disclose to the Defendants all home/office/land-line telephone numbers of Howard Adelman (Michael's father), Judith Sclawy-Adelman (Michael's mother), and Elisabeth Sclawy-Adelman (Michael's sister). For each, Plaintiffs shall disclose the name(s) of the provider(s), and produce copies of any bills, ledgers, logs and correspondence in their possession, custody or control, relating to these telephone numbers.
- 4. For each electronic device currently or formerly used to communicate on each telephone number described above, Plaintiffs shall identify the device with specificity and state its current location, dates of existence and all persons who have had custody and/or use of it.
- 5. Plaintiffs shall preserve each device disclosed in #4 above in its original condition and shall not alter, repair, modify and/or change the condition of each device.
- 6. Plaintiffs shall state whether Michael Adelman's cellular telephone has at any time been removed from the evidence bag it was received in from the Collier County

Sheriff's Department, and if it has, shall provide a detailed description of what occurred

as well as the names, addresses and telephone numbers of any and all individuals who

have interacted with it.

7. No destructive or non-destructive testing for Michael Adelman's cell

phone shall be permitted unless written protocol for testing is agreed upon by all counsel.

8. Plaintiffs shall disclose whether any consultant has evaluated the

cellphone.
