JOINT MOTION FOR AMENDED SCHEDULING ORDER

 - 5. The Court issued its Claim Construction Order on December 1, 2011. (D.E. 194).
- 6. To accommodate additional time for fact and expert discovery, the parties jointly propose further amending the case schedule as follows:
