On Friday, Apple produced documents bearing bates numbers FL-Apple0100334- FL-Apple0100968. These documents appear to be prior art references, but many are illegible and the indicated custodian of every document in the production is "None." In addition, a number of the documents are heavily or entirely redacted.
