Hi Cody,

I just left you a voicemail. Given our close of discovery in the middle of January, I cannot agree to withdraw Apple's subpoena because there will not be enough time for us to serve a new one if it turns out Motorola does not produce the discovery we need. That said, as I confirmed during our conversation the other day, we would prefer to get discovery from Motorola rather than bother any third-parties, so we do not plan to actively pursue further information from you at this time. If we can let the subpoena sit as a placeholder, I should be able to confirm whether we need any discovery from Bright House after we see what Motorola produces. I'm happy to agree to an extension on Bright House's objections, if needed.
