1. The plaintiff is a resident of Needham, Norfolk, Massachusetts and a citizen of the United States.

2. The defendant, Internal Revenue Service, is an agency of the U.S. Government.

3. This court has jurisdiction over this matter pursuant to my belief that a question of Federal Law has been violated.

4. In 2001, Edward Davis' request for abatement of \$248,049.38 and refund of \$381.42 was denied. This was in connection with Trust Fund payments not made by General Ship Corporation (ID# 042716030) for the periods ending 12-31-94 and 3-31-95 and 6-30-95.
5. Edward Davis was an officer of this company but was not the person responsible for or authorized to approve any payment to any party due to serious cash flow problems. The CEO made all the decisions here. Edward Davis was not the responsible party.
6. As far as I know, there has been no attempt by the IRS to collect these monies from any other person, including the CEO.
7. Other people formerly involved with the company agree with my version of events. The company ceased operations in 1995.

8. After hearing the facts in this case, I request that the court reverse the decision by the IRS and allow the abatement requested. I will gladly present these facts.
9. Wherefore the Plaintiff demands judgment against the defendants
10. I request a trial by jury.
