Should you choose not to sign the license and should you continue to exploit the cheer, you may be liable for statutory damages in the amount of \$150,000.00 per use, pursuant to 17 USC §504 and attorney fees pursuant to 17 USC §505.

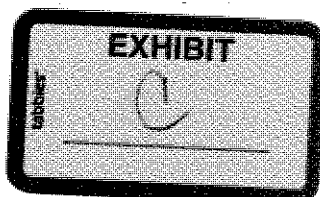
