I am an attorney with Boies, Schiller & Flexner LLP, and I serve as county counsel for Palm Beach County for Obama for America. Unless the context indicates otherwise, I make this declaration on the basis of personal knowledge, and if called to testify as a witness, I could and would testify competently hereto.
- 2. In my role as county counsel for Obama for America, I personally visited multiple early voting locations in Palm Beach County to monitor the progress of early voting.
- 3. During the eight (8) days of early voting in Palm Beach County, I visited the early vote sites at Boca Raton City Hall, Riviera Beach City Hall, the Palm Beach Gardens Library, the Hagen Ranch Road Library and the West Boynton Branch Library.
- 4. During these visits I witnessed voting lines that stretched hundreds of people deep and out to the streets surrounding the early voting locations. At several of these sites voters reported waiting in line in excess of three (3) to four (4) hours before being able to cast their ballots.
- 5. While monitoring the voting at these locations, I witnessed voters leave the voting lines and voting site without casting a ballot.
