<u>DECLARATIO</u>	ON OF TAKING		

TO THE HONORABLE. THE UNITED STATES DISTRICT COURT:

Pursuant to the authority delegated by the Secretary of the Interior to the Solicitor of the Department of the Interior on February 17, 1959, under subparagraphs (6) and (7) of 210.2.2, Departmental Manual of the Department of the Interior, 24 F.R. 1348, as renumbered (5) and (6) in the Departmental Manual, as redelegated by the Solicitor, I do hereby make and cause to be filed this Declaration of Taking and declare that:

- 1. The land hereinafter described is taken under and in accordance with the authority set forth in Schedule "A" annexed hereto and made a part hereof.
 - 2. The public uses for which said land is taken are also set forth in said Schedule "A".



3. A description of the tract of land taken and the estate taken for said public uses are

set forth in Schedule "B" annexed hereto and made a part hereof.

4. The names and addresses of purported owners and other parties who may have or

claim an interest in the land are set forth in Schedule "C" annexed hereto and made a part hereof.

5. A plat showing the land taken is annexed hereto as Schedule "D" and made a part

hereof.

6. The sum estimated as just compensation for said lands, which aggregates 2.51 acres,

including any and all interests taken in said land is SIX THOUSAND THREE HUNDRED AND

NO/100 DOLLARS (\$6,300.00), which sum I cause to be deposited in the registry of the court

for the use and benefit of the persons entitled thereto. I am of the opinion that the ultimate

awards for said land probably will be within any limits prescribed by law on the price to be paid

therefor.

SCHEDULE "A"

EVERGLADES NATIONAL PARK

AUTHORITY FOR THE TAKING

The authority for the taking of the land is under and in accordance with the Act of Congress approved August 1, 1888, 25 Stat. 357, as amended, 40 U.S.C., sec. 257; the Act of Congress approved February 26, 1931, 46 Stat. 1421, as amended, 40 U.S.C., sec. 258a, the Act of May 30, 1934, 48 Stat. 816, as amended, which authorized the establishment of Everglades National Park; the Act of December 13, 1989, 103 Stat. 1946, 16 U.S.C., sec. 410r-5, et seq., which expanded the boundaries of Everglades National Park; and the Land and Water Conservation Fund Act of 1965, 78 Stat. 897, as amended, 16 U.S.C., sec. 460l-4, et seq.; and under the authority of the Department of Interior and Related Agencies Appropriation Act, 2001, 114 Stat. 922, which Act appropriated funds for such purposes.

PUBLIC USES

The public uses for which said land is to be taken are as follows: The land is required to modify the boundaries of Everglades National Park and to provide for the protection of lands, waters, and natural resources within the park for the benefit and enjoyment of future generations. The said land has been selected for acquisition by the United States of America for said purposes, and for such other uses as may be authorized by Congress or by Executive Order.

All that certain tract or parcel of land lying and being situated in the County of Dade, State of Florida, and being more particularly described as follows:
