NOTICE OF SENTENCING DATE

TO: DEFENDANT, DEFENSE COUNSEL, U.S. ATTORNEY'S OFFICE, U.S. PROBATION AND U.S. MARSHAL:

By direction of the Honorable JAMES C. PAINE, United State District Judge, **YOU ARE HEREBY ORDERED** to appear in the United States District Court for the Southern District of Florida on **Thursday, May 23, 2002 at 8:30 AM** for imposition of sentence. ANY MOTION TO CONTINUE THIS SENTENCING DATE MUST BE FILED IN WRITING AT LEAST 14 DAYS PRIOR TO THE DATE SET. ALL PARTIES MUST COMPLY WITH ADMINISTRATIVE ORDER 95-02. (Copy given to counsel)

IT IS FURTHER ORDERED that the U.S. Attorney's Office immediately provide the U.S. Probation Department the necessary information to prepare the Prosecution Section of the Presentence Report.
