O.J. would always call 50 cent "Baby O.J."

Rapper 50 cent is Angry and wants to do harm to me because I'm currently suing 50 cent in U.S. District Court, Middle District of Georgia, Albany, for Copyright infringement. All of 50 cents lyrics on his new Album "Curtis" were written by me in all of 2002. 50 cent promised to compensate me for the lyrics, but I received nothing. Before I sued 50 cent, I've called him numerous times in Atlanta from the prison phone at Ft. Williamsburg. 50 cent would threaten me with O.J. Simpson. 50 cent knew O.J. got away with murder once and he could do it again. I felt scared when 50 cent mentioned O.J., because the 10 times when I met O.J. in the past at 50 cents Atlanta Home, O.J. would pick on me, show off. O.J. used to kick my head like a football. One afternoon, O.J. and 50 cent both stretched me by my arms in opposite directions. I was always intimidated by O.J. Simpson and still is.

On 9-18-07, 50 cent made O.J. Simpson a financial deal. 50 cent will arrange to bail O.J. Simpson out of the Clark County Jail in Las Vegas and pay all his legal fees. In return, 50 cent wants O.J. Simpson to come to Ft. Williamsburg to hunt or kill me. This is in relation to the lawsuit I filed on 50 cent. 50 cent wants to silence me, so I can't testify against him.

Clerk of the House of Representatives Jeff Trandahl contacted 50 cent after O.J. Simpson's arrest. Jeff Trandahl is angry with me because of a secret document the Supreme Court accidentally sent

me with my appeal papers, about the unconstitutionality of title 18 USC 3231 that I won't return to Jeff Trandahl. Defendant Trandahl does not want the public to know the contents of this document. I'm going to share it with the court so you can understand:

Title 18 of the criminal code (Public Law 80-772) is unconstitutional. The clerk of the House of Representatives, Jeff Trandahl refused to sign letters in response to requests for information. Finally, a letter was received from the clerk of the House, Trandahl, in which he admitted that Public Law 80-772 was passed by the House in 1947, but was never voted on again by the House in 1948 (Even though the senate amended it in 1948). Therefore, a different bill passed the House in 1947, then passed the senate in 1948, rendering it unconstitutional and void. Further research showed approximately 9 constitutional flaws in the bill, any of one which rendered it void. When my form of the argument was presented to the district courts, they tried to dodge the issue or deferred it to a magistrate (who has no constitutional authority) to avoid it. It appears that the issue of the validity of title 18 of the criminal code and 18 USC 3231 is still a question.


